Investment Aim

The Fund aims to track the HSBC Economic Scale Index United States (the US Index) by investing in securities that are included in the US Index. The Fund uses a technique called 'full replication', which involves holding all of the assets held in the US Index. It can also use a strategy called 'optimised replication' in specific circumstances – for example, if the size of the Fund is too small to allow the full replication of the index. Or, if it is not cost effective to do so. Optimised replication allows the Fund to invest in a sub-set of securities held in the index, to help us track it effectively. The Fund may also invest in financial derivative instruments. These are financial instruments whose value is based on underlying assets, for example bonds, stocks, currencies. The Fund uses derivatives to protect against financial risks (hedging) and to manage cash flows. The Fund can also use derivatives to gain access to parts of the US Index, when investing directly isn't possible.

Risk Disclosure

It is important to remember that the value of investments can go down as well as up and you may not get back the amount originally invested. Where overseas investments are held the rate of currency exchange may cause the value of such investments to go down as well as up. This fund invests predominantly in one geographic area; therefore any decline in the economy of this area may affect the prices and value of the underlying assets.
